

## PGY2 Infectious Diseases Pharmacy Residency

The residency is conducted at multiple sites in the division to expose the resident to facilities of varying sizes and patient populations. Additionally, the resident gets experience leading a stewardship team and completing ID-related projects at the facility where their clinical staffing experience is conducted.

- Access to corporate gym/workout facility

### After Residency
